OUR WARRANTY

Seller warrants the Dog to 1) be in good health to the best of her knowledge, 2) all shots and worming to be up to date and 3) be free from obvious health conditions or defects at the time of transfer to the Buyer. To validate this warranty, the Buyer must have the Dog examined by a licensed veterinarian within 72 hours of acquiring the Dog. The Buyer must provide the veterinarian with the medical record for continuing care and vaccinations to be properly scheduled. Should you, the Buyer, neglect to take the Dog and medical record to a licensed veterinarian for this exam within the time-period required, you will accept immediate and full responsibility for the health of the Dog, and indemnify Seller against any and all further claims regarding the Dog. All vet bills are the responsibility of the Buyer. If there is found to be a serious incurable health condition or defect, the Dog and the written vet statement must be returned to Seller within 72 hours of Buyer becoming aware of the serious incurable health condition or defect. If the Dog must be returned to Seller it will be exchanged for one of equal value, when one is available. The Buyer agrees to keep all medical needs up to date. In the event that the Buyer is no longer able to care for the Dog, it will be returned to the Seller with no cash refund, in accordance with the "Limitations on Transfer" section of this contract (below). There are no other representations or warranties which are not already contained herein. This contract is the entire agreement between the parties.

SELLER'S WARRANTY OF OWNERSHIP

The Seller hereby warrants to Buyer that it is the legal and true owner of the Dog and that it has the unqualified right to sell the Dog. The Seller further warrants that the Dog is sold free and clear of any liens, security interests, mortgages, or other encumbrances.

12 MONTH GOOD HEALTH WARRANTY

(Except as otherwise provided herein) The Dog is warranted against congenital defects for a period of 12 months from the date of this sale. If such defects are discovered and proven, a replacement dog of the same breed, sex, approximate age, and value from seller's lines will be given to the Buyer at no charge, provided, however that no such replacement will be provided if the Buyer fails to provide a letter of explanation from an examining licensed veterinarian, and Seller is given the opportunity to have the Dog examined for confirmation by Seller's licensed veterinarian. If the Dog dies and a congenital defect is suspected, the results of a valid necropsy of the the Dog must be provided to Seller for the warranty to be in effect. All costs of a necropsy shall be paid for by the Buyer. If the Buyer does not take the Dog to an examining licensed veterinarian within 72 hours of this sale, this 12-month Good Health Warranty is null and void. If a replacement dog is provided, the terms and conditions of this bill of sale will apply to that dog, including a veterinarian examination by the Buyer, and all references to the Dog herein shall be taken to mean the replacement dog. There is no monetary refund.

Disorders that may be caused by factors other than congenital, such as environmental factors, are not covered under this bill of sale, nor are uneven bites, umbilical hernias, or medial patellar luxation, which is common and normal in small breed dogs. Examples of such other disorders not covered by this warranty include parasitic infestations, coccidia, kennel cough, demodectic mange, scabies, rabies, thyroid dysfunction, growths, allergies, and other auto-immune system maladies. These are not life-threatening ailments and are treatable.

LIMITATIONS ON TRANSFER

Under no circumstances will the Buyer sell, lease, or give the Dog to any pet shop, research laboratory, or similar facility (including dog pounds or rescues). If the Buyer can no longer provide a home for the Dog, the Buyer agrees to notify the Seller before making any transfer and the Seller agrees that it will help find a new home for the Dog or will reclaim the Dog at the Buyer's expense. If the Dog is returned pursuant to this contract, the Buyer agrees that it will help with any legal actions necessary to transfer ownership and registration of the Dog to its new owner.
